




## How does it all fit together?

#### **Enhancing Product Safety**

- •Consumer Protection: Standards help to minimize risks associated with harmful chemicals, allergens, and contaminants in cosmetics.
- •Toxicological Testing: They provide guidelines for testing potential toxic effects of ingredients on skin and overall health.
- •Microbiological Safety: Standards ensure products are free from harmful microorganisms.



#### Regulatory Harmonization

- •Global Trade Facilitation: By aligning with international standards, companies can export their products more easily across borders.
- •Reduction of Barriers: Standards reduce discrepancies in regulations between countries, fostering smoother trade relationships.
- •Compliance Frameworks: Many countries adopt international standards like ISO, making it easier for companies to meet multiple regulatory requirements simultaneously.



#### **Quality Assurance**

- •Consistency: Standards ensure consistent quality across product batches, boosting consumer trust.

- •Quality Control: Defines requirements for manufacturers to ensure consistent quality across all cosmetic products.
- •Raw Material Assessment: Provides guidelines for evaluating the safety and efficacy of raw materials used in cosmetics


